

# **TruNorthern Federal Credit Union Ticket Giveaway**

## **Terms and Conditions**

**Binding Agreement.** By participating in the Ticket Giveaway (“Giveaway”), you are bound to these Terms and Conditions (“Terms”) and indicate your agreement to them. All the credit union’s (“TruNorthern”, “Sponsor”, “TruNorthern FCU”) decisions are final and binding.

**Privacy.** The personal information collected, processed and used as part of the Giveaway will be used in accordance with the credit union’s Privacy Policy, which is available by link on the credit union’s website, located at <https://www.trunorthernfcu.org/privacy.php>

**Eligibility.** Eligibility is for those who are at least eighteen (18) years of age at the time of entry. Sponsor has the right to verify the eligibility of each entrant.
